



**Northwest Indiana District 1 Firefighter Training Council

Student Waiver**



WHEREAS, the undersigned is participating in training sponsored by the NWI District 1 Firefighter Training Council (NWI D1 FTC);

NOW, THEREFORE, for and in consideration of the privilege of participating in such Training provided by or on behalf NWI D1 FTC, the undersigned, for himself, his personal representative, heirs, and next of kin:

1. hereby releases, waives, discharges, and covenants not to sue NWI FTC, its employees, shareholders, officers, directors, equipment suppliers, agents, and representatives for any and all loss or damage, and any claim or demands therefore on account of accident, injury, illness, death, or harm of any type arising out of or related to the Training, whether caused by the negligence of any Releasee or otherwise.
2. hereby agrees to indemnify and hold harmless the Releasees and each of them from any loss, liability, damage, or cost they may incur arising out of or related to the Training whether caused by the negligence of Releasees or otherwise.
3. hereby assumes full responsibility for any risk of bodily injury, death, or property damage arising out of or related to the Training whether caused by the negligence of Releasees or otherwise.
4. hereby acknowledges that the activities involved in the Training are of a hazardous nature and contain inherent risks of serious injury and/or death and/or property damage. The undersigned also expressly acknowledges that injuries received may be compounded or increased by negligent rescue operations or procedures of the Releasees. I also understand that the volunteer activity set forth above is undertaken by me on a completely voluntary basis. I make this decision by choice and my participation in this activity is undertaken knowing that certain risks may be involved. These risks include, but are not limited to, property loss or damage and physical or emotional injury, temporary or permanent, and death. I recognize that the locations in which I am working can be dangerous, in day or in night, and I voluntarily assume the risk of these dangers by choosing to participate in the activity. I understand that the NWI District 1 Fire Training Council does not assume any risk or liability due to my participation in this activity. I understand this release applies to all claims for property loss, injury or illness, or death or any other damages suffered by me, now or in the future, whether suffered in transport to the activity or during the activity itself.
5. hereby agrees that this Liability Waiver extends to all acts of negligence by the Releasees, including negligent rescue operations, and is intended to be as broad and inclusive as is permitted by the laws of Indiana and that if any portion thereof is held invalid, the undersigned agrees that the balance shall continue in full force and effect.
6. hereby agrees to release, waive, discharge, and covenants not to sue any Fire Department, State, County, Town or City, where said training is held or conducted.

I, THE UNDERSIGNED, HAVE READ THIS WAIVER OF LIABILITY, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
